3. **Terms and Conditions:**

- I) Bids should be accompanied by Earnest Money of Rs 5000/- (Rupees five thousand only) in the form of Demand Draft (DD) drawn in favour of **Principal, Bhagalpur College of Engineering** payable at **Bhagalpur** without which the bids will not be considered. The Demand Draft along with the sealed bids should be put together in an envelope super scribed "Bid for sale of condemned vehicles" and send to the address as indicated above.
- II) The bid amount should be for any vehicles may be quoted. Separate bid for each vehicle may be considered.
- III) The bidders will not be allowed to withdraw their bids, failing which their Earnest Money Deposit (EMD) will be forfeited.
- IV) In the event of acceptance of bids, the successful bidder (i.e., highest bidder) will be required to deposit the full bid amount by means of DD drawn in favour of **Principal, Bhagalpur College of Engineering, Bhagalpur within 3 working days from the date of the acceptance of the bid v**. The Earnest Money Deposit (EMD) of the successful bidder will be released only after the deposit of sale proceeds. The EMD will not be adjusted as sale proceeds and it will be forfeited in case of failure in honouring the bid. In all cases, no interest will be paid on EMD.
- V) The vehicles will be delivered only after the receipt of full payment and after the successful bidder submits documentary evidence in support of residential status viz. Ration card/Voter ID card/Passport in case of individual and Registration Certificate in case of firms etc. The sold vehicles have to be lifted at the successful bidder's own expenses within 5 days of final payment beyond which this office will not be responsible either for safe custody or for any loss or damage to the said vehicles.
- VI) The successful bidder will also be responsible for getting the Registration Certificates of the vehicles transferred in his name (if/as necessary/required by law) at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
- VII) The vehicles will be disposed off on "as is where is" basis and no guarantee for its worthiness or quality will be given by this office.


